Sub: Extension/continuation of provisional affiliation for existing course i.e. B.Ed. 02 years full time degree course (200 seats) for the academic session 2023-24 to SJS International College of Education, Dikadla Complex, Samalkha, Panipat

This is in reference to the meeting held on 24.02.2023 under the chairmanship of Hon'ble Vice-Chancellor in which you were present.

It is intimated that in view of the directions issued by Higher Education Department, Haryana, Panchkula vide Memo No. KW 12/6-2003 C-II(3) dated 02.07.2020 and stay order granted by Hon'ble High Court of Punjab & Haryana in CWP Nos. 17228 & 15769 of 2021 the extension / continuation of provisional affiliation is granted to your institute for the academic session 2023-24 for running existing course with earlier sanctioned intake i.e. B.Ed. (Bachelor of Education) - 02 years full time degree course with annual intake of 200 students without carrying out the physical inspection of your Institute.

The extension / continuation of provisional affiliation for running B.Ed. - 02 years full time degree course (200 seats) to your institute for the academic session 2023-24 is subject to the following conditions:-

1. The final verdict by Hon'ble court of Punjab & Haryana in CWP Nos. 17228 & 15769 of 2021 etc. and decision of Department of Higher Education, Haryana (if any) will be applicable on your Institute.
2. That the Institute shall ensure the requisite infrastructural facilities, library books, labs, Faculty & Staff and other support systems, etc. as per the norms of N.C.T.E., University and Department of Higher Education, Haryana.

3. In reference to the undertaking dated 19.07.2023 submitted by you, the Institute will complete the process of recruitment of Faculty and Staff as per the norms of the N.C.T.E. and University.
4. The Institute will ensure to impart education as per the norms laid down by the University, DHE and NCTE. Further, the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time. Further, it is made clear that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.
5. In compliance of the directions issued by Higher Education Department, Haryana, Panchkula vide Memo No. KW 12/6-2003 C-II(3) dated 02.07.2020 (copy attached), the college shall upload the data on the web portal/MIS link of Higher Education Department, Haryana regarding infrastructure, faculty etc. and the same will be shared with the University through a link.

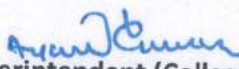

**Subject: Directions in respect of NCTE approved colleges of Education
affiliated to State Universities in Haryana.**

Kindly refer to the subject cited above.

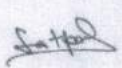
I have been directed to convey that the State Govt. has taken the
following decisions:-

1. Annual inspection in respect of NCTE approved Colleges of Education may be stopped and shall be carried out after every 5 years.

Further, the Higher Education Deptt. will create an online web portal/ MIS link where all Self Financed B.Ed Colleges shall upload the data regarding infrastructure, faculty, etc. by 31 October every year and the same will be shared with the affiliating Universities through a link.

2. Selection of teaching faculty shall be done as per following procedure:-

- i) Qualification of the teaching staff shall be as NET/Ph.D holder/ as per NCTE norms.
- ii) In the Selection Committee, the University nominee shall be a Professor of the University/Principal of aided college/college/an approved teacher from any of the Self-financing College of Education.
- iii) Interview may be conducted even if one candidate is available as per norms.
- iv) TA/DA of selection committee member will be as per norms and sitting fee Rs. 3000/- per subject shall be rationalized for all Universities. Further the same nominee shall be allowed to conduct

selection for 2/3 subjects on the same day since the number of applicants are less in these colleges.

3. With regard to online counseling for admission of B.Ed and M.Ed. courses, 1st counseling and 2nd counseling shall be conducted by the concerned University. The 3rd counseling shall be conducted from 15 October to 31 October and the concerned college is authorized to make admissions at its own level but after 31 October, no admission shall be made so that the academic calendar of concerned University/ NCTE/ UGC is adhered to.
